Hon. Amber-Jade Sanderson MLA Minister for Environment; Climate Action; Commerce WA

Amber-Jade Sanderson was elected as the Member for Morley in March 2017, after serving almost four years as Member of the Legislative Council for the East Metropolitan region. In the first term of the McGowan Government Minister Sanderson served as the Parliamentary Secretary to the Premier; Minister for Public Sector Management; State Development, Jobs and Trade; Federal-State Relations and as Parliamentary Secretary of the Cabinet. Amber-Jade was crucial in delivering Western Australia's Voluntary Assisted Dying laws. As the Chair of the Joint Select Committee on End of Life Choices she oversaw extensive community consultation, a year-long parliamentary inquiry and debate, and finally the passing of the Voluntary Assisted Dying Bill.

On 19 March 2021, Amber-Jade was sworn in as Minister for Environment; Climate Action; Commerce.

Amber-Jade grew up in Bayswater until the age of five, before moving to England in the mid-1980s with her family. Seeing the effect policies had on low-income families saw her forge a career, on her return to Australia, in the union movement campaigning for a fairer society and the rights of lower income earners. Throughout her career, Amber- Jade has been passionate about social justice issues.

Notable entities he has been affiliated with include the United Nations, World Bank, Government of South Australia, BHP Billiton, Santos, SA Water, Worley Parsons,

City of Salisbury, Siemens, and the University of Adelaide. Hemant is founder of Circular Economy Alliance Australia (CEAA), an impact agency for global coalition in leadership and capacity building in the Circular Economy. Hemant is a prolific public speaker, a passionate advocate for collaboration between governments, agencies, experts, and communities to solve complex environmental issues.

Marcus Geisler CEO Eastern Metropolitan Regional Councils (EMRC) *Circular Economy in the WA Context*

Over the past 30 years, Marcus has built up experience in developing strategies, delivering projects and leading teams in the private and public sector, primarily in waste management and resource recovery. In the private sector he was engaged in senior strategic and operational roles for companies including Suez, Thiess and Coates Hire in Europe, Australia and Asia. From 2008 to 2019 Marcus served on the Western Australian State Government Waste Authority Board. From 2012 as the Board's Chairman, which culminated in the development and launch



of the 'across government' WARR strategy 2030 in 2019, introducing the Circular Economy and Behaviour Change as guiding concepts. Marcus joined the Eastern Metropolitan Regional Council (EMRC) in the same year to focus on implementation of the WARR strategy, enabling the 'linear to circular' transition through Local Government. Marcus has qualifications in economics and trade, is an alumni and fellow of the Australian Institute of Company Directors and is involved in not-for-profit organisations and government advisory boards.

As the CEO of Coreo, Ashleigh is unwavering in her pursuit of systemic change. With recognition of her strategic foresight and experience in the private and public sectors Ashleigh was awarded the Lord Mayor of Brisbane's 2020 Young Business Person of the Year Award; is a Prime Minister's Scholar; an Australian ASEAN Emerging Leader; was an invitee to the 73rd United Nations General Assembly; and is an Ellen MacArthur Foundation Circular Economy Champion, a title granted to only a handful of people worldwide. Ashleigh has had an audience with two

Australian Prime Ministers, travelled with the Federal Minister for Trade, Tourism and Investment to Japan on a Future Leaders, Future Cities Business Mission and represented Australia at the World Circular Economy Forum. Ashleigh is an Associate Professor of Griffith University, holds a Bachelor of Environmental Health Science with Faculty Commendation for academic excellence, 1st Class Honours in Environmental Management, and the highest honour a university can bestow; the University Medal.

Brooke Donnelly CEO Australian Packaging Covenant Organisation (APCO) Delivering on the Circular Economy

Brooke Donnelly has spent her career working in product stewardship, collective impact, recycling and sustainability. In her current role as CEO of the Australian Packaging Covenant Organisation (APCO), Brooke leads APCO's strategic direction to ensure effective collaboration between industry, government and consumers to drive significant positive environmental and circular economic activities for Australian communities. APCO is tasked with the development of a circular economy for packaging in Australia.

This includes facilitating delivery of Australia's 2025 National Packaging Targets and the ANZPAC Plastics Pact by driving change in the packaging value chain to reduce and redesign packaging for recyclability or reuse, achieve higher collection rates and improve the quality/ demand of recycled material streams/content. Brooke has a Masters in Sustainable Business Management, is an alumnus of the Cranlana Centre for Ethical Leadership, the Australian Institute of Company Directors and the co-founder of the Product Stewardship Alliance, a voluntary group working to accelerate Australia's journey to a circular economy through product stewardship.

Use of Digitalisation and Sharing Platforms for the Circular Economy

Cameron McKenzie is the CEO of ASPIRE. ASPIRE is an online platform and marketplace that helps drive innovation in the transition to a circular economy in Australia. Cameron started his career in construction and was always bothered by the amount of waste that this industry creates. He has several trade skills under his belt including Engineering and Carpentry but has also studied to acquire a Master's degree in Entrepreneurship & Innovation and holds an MBA. He is the winner of the Fillion Award for Entrepreneurial Excellence and worked

closely with CSIRO and Kingston Council during the transition phase of moving ASPIRE out of CSIRO and into a new entity and upgraded platform. ASPIRE now has the independence to branch out beyond Victoria to be a national program and more recently, connecting to Hong Kong circular economy stakeholders.

Brad Lacey Chief Operating Officer EMRC **Stephan Fitzpatrick** Waste and Resources Recovery Specialist EMRC *Hazelmere Resource Recovery Park Tour*

Resource recovery parks are designed to receive, process, separate and repair a community's discarded materials, with the goal of selling the re-purposed materials to markets and the community. Resource recovery parks demonstrate sustainability in waste management and there are many examples of successful resource recovery parks across Australia and the world. Hazelmere Resource Recovery Park is home to Western Australia's first



mattress and timber waste recycling operations. The purpose of the park is to recover resources from waste streams thus diverting waste from landfill and providing an opportunity to re-use materials. The Hazelmere Resource Recovery Park is part of the EMRC's Resource Recovery Project, an integrated plan for sustainable waste management in the Capital region.
